These items will be available for auction, with a minimum starting price of only NT\$150 per piece. It is important to note that besides completing the bidding form and providing the requisite deposit, the bid envelope must also clearly indicate the auction date, time and case number. The bid envelope should be sent via double-registered mail to the P.O. Box 198 at Taipei Changchun Road Post Office one day prior to the auction date. Failure to comply with these requirements may result in the bid being considered invalid.
